President Rtn Dr Sanjay Kalra welcomed the Chief guest CA Mukul Bansal in our meeting on 31st March 2023 on the last of financial year 2022-23, the most appropriate day to have a chartered accountant to address us about Balance Sheet, a non-financial one not for a company or business, but about Life! His formal introduction was given by PE Rtn Jeeten Bhambri.

Mr Mukul Bansal has done Bachelors in Commerce from Panjab University, Chandigarh in 1979. He is Fellow member of 'The Institute of Chartered Accountant of India', New Delhi. A Qualified Chartered Accountant, he has experience of over three decades. He is a Senior Partner in M/s Datta Singla & Co., Promoter & Chairman

of M/s Embee Financial Services Ltd. (EFSL), Promoter and Chairman of M/s Embee Insurance Brokers Limited (EIBL). The Company is the one of the first one in Northern India, other than Delhi, to get the license from IRDA, Hyderabad to act as Direct Broker in Life & non-life segment. He is also Promoter of M/s Embee IP services Pvt Ltd. The Company Registered under Insolvency and Bankruptcy Code, 2016 IBC. The insolvency process will be managed by licensed professionals. These professionals control the assets of the debtor during the insolvency process.

Matching Rotary with Judiciary

Rotary was born on February 23, 1905. We have just celebrated its 119th birthday. No ageing signs. The years and the decades have added to its strength and vitality. What is its health secret? What is its recipe? Its life story needs to be shared. It was extremely chilly evening (February 23) in Chicago. Paul Harris, a young lawyer (only 9 years into the legal profession) conceived Rotary. Three friends were invited. These four men belonged to four different countries, different faiths and different businesses and professions. All settled in USA. Paul shared his mind. He wanted to organise a group. Each one representing a different profession and a different business. To meet by rotation each week. This is how Rotary took its birth. Rotary is a global organisation of close to 12.5 million Rotarians of 36,904 clubs. Divided into 538 Rotary Districts. Spread over 172 countries. In India, Rotary has already completed its 100 years. It is growing and moving from strength to strength.

It was after the 2nd world war, in 1945, the US President, Harry Truman and British Prime Minister Winston Churchill came together to draft the UN Charter. There were 49 Rotarians on the drafting committee. Peace is Rotary's DNA. The Rotary theme for the year 2012-13 was: Peace Through Service given by RI President Sakuji Tanaka. Service beyond self. Service to humanity. UNO has completed 77 years. Rotary and UNO are partners in Peace. They are working together. Service is a formidable arsenal of Peace. The Rotary story and journey is soaked in Service to mankind.

I joined Rotary in 1977. I have enjoyed Rotary for 46 years. During these 46 years, I have been a witness to how Rotary has contributed in bringing Peace in the lives of millions of people around the globe. I was a young Law Professor at the Panjab University when I joined Rotary. The Lawyers and Judges are partners in doing justice. This is the best kind of service. Throughout my association as part of Rotary, I have connected Rotary with Legal and Judicial Coparcenary. Through my writings. Talks and memorial lectures. My entire effort was focused to spread Rotary culture in my varied surroundings: the law students, teachers, lawyers and judges.

Paul Harris, founder of Rotary was a lawyer. Rotary International President Jonathan Majiyagbe for the year 2003-2004 was a Senior Advocate of Nigeria. Rotary International President, Ron D. Burton (2013-14) was admitted to practice before the US Supreme Court. R.I. President Jennifer Jones (2022-23) holds a Doctor of Laws – LLD degree. The list is long. Former Chief Justices of India, late Justice Dr. A.S. Anand and late Justice M.M. Punchhi had been Rotarians. In India also, many lawyers, judges and law professors have been Rotarians. Rotary is a way of life which is 'service' oriented. Equally, the Legal and Judicial Coparcenary is also service oriented. Both are founded on the touch-stone of 'service'. What a blend. What a mix. What 'service' culture. The culture of this Coparcenary and of Rotary is a 'mosaic of service'.

Rotary has its 4-way test. Is it the truth? Fair to all. Will it build goodwill and beneficial to all. Judges find out the truth. Justice and Truth are twins. Truth and fairness are interwoven. When you speak the truth, you build up goodwill. Goodwill is beneficial to all. This blends both Rotary and Judiciary together.

The Rotary International Council on Legislation in 1989 provided "Rotary Code of Conduct". It laid down :

(i) Rotarians will act with integrity and high ethical standards in their personal and professional life; and (ii) Rotarians will avoid behavior which reflects adversely on Rotary or other Rotarians.

This Code of Conduct fully fits into the Code of Conduct of Judges. The word *Rotarian* be substituted with *Judge* *Rotary* be substituted with *Judiciary*. This Code of Conduct also covers the lawyers and Judges. Lawyers must act with integrity and high ethical standards in their personal and professional life.

Truly, Judges and Lawyers must avoid behavior which would reflect adversely on them and on the institution of Judiciary. Rotarians wear Rotary lapel. Judges add to their name Justice or Judge. They wear their robes. Once you become a Judge or Rotarian, automatically the Code of Conduct becomes operational.

M.C. Chagla was Chief Justice of Bombay High Court from 1947 to 1958. After being the Chief Justice, he lived for another 22 years. He occupied many other positions rendering service above self. He was no more on February 09, 1981. On August 15, 1985, his statute was unveiled outside Chief Justice's Court (No.52) where he presided for 11-years. The words inscribed read: "A great judge. A great citizen. Above all, a great human being". Without being a Rotarian, he was a true Rotarian.

Nani Palkhiwala was a Court Room genius. Unique in every respect. At heart, he was a true Rotarian. His name and fame was not for the fees that he charged for his professional skills and services. Actually, he would do many cases free for good public causes. His father nurtured in him compassion and kindness for the less privileged. He created many Charitable Trusts, gave donations to Charitable Institutions. A prominent Eye Hospital in Madras needed financial help. The Director of the Hospital was invited to dinner. After the dinner, when Nani came down to see him off, he handed him a closed envelope containing a personal cheque of Rs. 25 million with the words, "If you need more, do not hesitate to ask." In 1997, Justice Kuldip Singh of the Supreme Court of India presented Nani a citation on behalf of various Rotary Clubs of Bombay. The citation reads: "One feels that he is not a man of this world but someone from outside. I have many times tried to explain him as a man. But it is very difficult. One can only feel his essence and enjoy as one enjoys the fragrance of a flower or the smile of a child. He is like a cool breeze on a warm sunny day. This is Nani, the gentleman."

Justice H.R. Khanna occupies unique position on the judicial map of India. He was born on July 3, 1912. He was no more on February 25, 2008. He played his innings for 96 years. A life of fulfillment. A life of sacrifice. A life full of service. His portrait continues to adorn Court No.2 of the summit court of the country. It is reminder of the sacrifice he made. He never came to occupy Court No. 1 as the Chief Justice of India. He was superseded because of his *Habeas Corpus* decision. He was a true embodiment of Judicial and Rotary culture. He practiced Rotary values during his entire judicial career. Rendering justice is the best kind of service to humanity. Judges make Rule of Law inter-act with Rule of Life. Let the coparcenary of Lawyers, Judges and Rotarians work in unison. This coparcenary would weave service culture for the good of humanity. It is big comfort to know that some of the best Poetry was written by Milton. He was blind. Some of the best Music was composed by Beethoven. He was deaf. One of the greatest Presidents was Franklin D. Roosevelt. He served from a wheel-chair. Basically, they were good human beings. This coparcenary is also of good human beings. This is best recipe for building up Legal and Judicial Coparcenary.

A. PP Dr. VJS Vohra inspired me to join Rotary Club Chandigarh Midtown in 2007. PP RK Luther was my mentor. I was fortunate to attend Rotary International Convention in the same year and got the opportunity to interact with highly committed people. This further enlightened and motivated me to do community service.

Q. How do you rate your tenure of President-ship of the club?

A. I served as the President of the club in 2013-14. While constituting the board, I preferred taking the first timers. Though, there were many apprehensions, everything went well which strengthened my belief that if you trust the team, it can do magic. I successfully executed many projects like distribution of school desks, E-Learning Project for schools with underprivileged children and heart surgery of a poor girl child. I experienced that if you do something sincerely, there is no dearth of resources. There was so much to learn from a group of highly intelligent, intellectual and dedicated to social service seniors. These seniors have the qualities of leadership, perseverance, humility and affection.

Q. Which positions did you hold at the District Level?

A. I served as the Assistant Governor, Assistant Trainer, District Chair WinS, District Chair CSR and Advisor to DG CSR to the full satisfaction of everybody.

Special children differ socially, mentally and physically from other children. They require special attention and can't be expected to sit in meditation, art, dance workshops, and sports sessions without prior preparation. They are enthusiastic but we have to break the information down into smaller units to engage them," says Sangeeta Jain, principal of SOREM (Society for Rehabilitation of Mentally Challenged), Chandigarh. So, when RC Chandigarh Midtown, RID 3080, hosted a special RYLA called *Vishesh* (special in Hindi) to commemorate the International Day of Persons with Disabilities, SOREM ensured "we had trained faculty to prepare the children for a fun-filled day."

This year, about 100 'special delegates' between ages 15 and 35 registered for the event, which was held at SOREM. "The atmosphere was filled with excitement and fun, as children with visual, hearing, and speech impairments, as well as those with mental and physical challenges, connected with each other enthusiastically," says club president Sanjay Kalra. "We were worried if we could keep the children occupied with the

activities, but they surprised us with their determination and confidence to keep going," he adds.

Kalra says that the event focused on the holistic growth of children and adults with special needs and enhanced their personal and leadership qualities through fun activities. "These children can do wonders if supported by the right people." Awards and certificates were given to the best performers while all children were given RYLA certificates.

Through RYLA *Vishesh*, says Kalra, "our club had the unique opportunity to demonstrate our concern for special children. The event helped to showcase the abilities of those with

disabilities and the transformative power of empathy, inclusivity, and compassion."

One of the sessions that was enjoyed thoroughly by all the participants was the dance workshop. "It was heartwarming to watch these children dance joyously without any inhibition," smiles the club president. The event was inaugurated by Deepak Dhiman, channel head and editor of *Zee News. Radio Punjab* was the official radio partner.

The club also organised a 'Rotary Walk with a Difference' to commemorate the success of Project Sahyog, which provided artificial limbs to amputees. ■

स्वास्थ्य सुविधा • अप्रैल से टेम्परेरी तौर शुरू होगा अस्पताल में तैयार हुआ टीबी हट, 28 को हेल्थ डिपार्टमेंट को करेंगे हेंड ओवर जनरल अस्पताल के परिसर में रोटरी ने बनाया टीबी हट

टीबी हट में डॉट रूम से लेकर लैब की भी होगी सुविधा, ओपीडी और मरीजों की एडमिशन अस्पताल में ही होगी

एक तरफ सरकार 2025 तक भारत को टीबी मुक्त करने की तैयारी में है। वहीं, दूसरी ओर पंचकूला में टीबी के मरीजों के इलाज को लेकर पहल की गई है। इसमें ट्यूबरकुलोसिस यानी कि टीबी के मरीजों को इलाज जनरल अस्पताल के अंदर नहीं, बल्कि अस्पताल की बिल्डिंग के बाहर टीबी हट में मिलेगा। टीबी के मरीजों के डायग्नोस के लिए इस टीबी हट का सेटअप रोटर क्लब ने तैयार किया है, जिसे क्लब यानी कि 28 मार्च को हेंड ओवर किया जाएगा। इस सेटअप को ग्राउंड फ्लोर पर ही बनाया गया है। इसका ज्यादातर काम पूरा हो गया है, जिसके बाद अब अगले दो दिन के बाद यहां पर शिफ्टिंग का काम शुरू करवा दिया जाएगा। वहीं, अप्रैल के शुरुआत में इसे टेम्परेरी तौर पर शुरू भी किया जा सकेगा। इस दौरान जो भी कमियां दिखेंगी, उसे भी साथ के साथ ठीक करवाया जाएगा।

दूसरे मरीजों के साथ नहीं होगा टीबी के मरीजों का कॉन्टैक्ट

अस्पताल की बिल्डिंग से बाहर टीबी हट बनाने का फैसला इसलिए भी लिया गया है क्योंकि, इन मरीजों का इम्यून सिस्टम काफी कमजोर होता है। इनकी दवाइयों का कोर्स भी लंबा चलता है, ऐसे में इन मरीजों को दूसरे गंभीर बीमारियों से ग्रस्त मरीजों से दूर रखना जरूरी होता है। जनरल अस्पताल में चलने वाली चेस्ट एंड टीबी ओपीडी में ही एक साथ सभी मरीज आते हैं। दूसरी ओपीडी के भी काफी ज्यादा मरीज एक-दूसरे के कॉन्टैक्ट में आते रहते हैं। इससे बीमारी फैलने का चांस भी काफी ज्यादा हो जाता है।

टीबी हट बनकर तैयार हो गई है और अब इसमें कुछ इलेक्ट्रिक वर्क किया जाना है। यहां पर एसी से लेकर कंप्यूटर और वायरिंग का भी काम होना है। आने वाले दिनों में गर्मी शुरू हो जाएगी, जिस कारण अब यहां पर एसी लगाने के लिए भी प्लान किया जा रहा है। इसमें तकरीबन 6 लाख रुपए का और बजट मिलने का इंतजार है। इस बजट को लेकर अगले महीने तक मिलने की उम्मीद है। ये भी प्लानिंग है कि बजट ज्यादा मिलता है तो इस बिल्डिंग को सेंट्रलाइज एसी से लेस तैयार किया जाएगा।

इस सेटअप में लैब से लेकर डॉट सेंटर भी

टीबी के इन मरीजों को ना तो एक से दूसरे ब्लॉक में जाना पड़ेगा। इसके अलावा न ही बिल्डिंग से बाहर डायग्नोस करवाना पड़ेगा। इन्हें जो डाइट मिलती है, उसके लिए भी अलग-अलग कमरों में चक्कर नहीं लगाने होंगे। इस टीबी हट में मरीजों के लिए ओपीडी से लेकर इनके स्पूटम, टूनेट, सीबीनेट जैसे सभी डायग्नोस होंगे। यहीं पर अब इन मरीजों के लिए दवाइयां देने के लिए सेंटर बनाया जाएगा। इसके अलावा अस्पताल में अलग-अलग जगह पर बैठा टीबी डिपार्टमेंट का स्टाफ भी इसी बिल्डिंग में शिफ्ट होगा। इस सेटअप में ही लैब से लेकर डॉट सेंटर बनाया गया है।

जनरल अस्पताल के परिसिस में टीबी हट का सेटअप तैयार हो गया है। एक-दो दिन में विभाग को हेंड ओवर हो जाएगा। इसके बाद स्टाफ और टीबी डिपार्टमेंट इसमें शिफ्ट किया जाएगा। इसे रोटर क्लब एक प्राइवेट कंपनी के साथ मिलकर बना रही है। अप्रैल फर्स्ट फ्लोर बनाने की भी है, लेकिन अभी फंड की दिक्कत है। टीबी के मरीजों को इधर-उधर कहीं नहीं भटकना होगा। एक छत के नीचे ही इनकी ओपीडी चलेगी, वहीं पर इन्हें दवाइयां दी जाएगी और वहीं पर इनके डायग्नोस के लिए टेस्ट किए जाएंगे। - डॉ. परचिवर सिंह, इंचार्ज, टीबी प्रोग्राम
